The IAP-Bengaluru Election Committee Office is not responsible for any delay due to any cause whatsoever in filling out the Nomination Form in the election process. No changes/corrections will be permitted after the submission of the Nomination Form and payment of the nomination fee.

A member can be nominated for more than one post but will have to withdraw from all other posts, except one post, before the last date of withdrawal, i.e.16/11/2023 by 5.00 pm, failing which, all nominations for all posts filed by that member will stand cancelled. A separate applicable nomination fee must be paid for each post nominated. The name of the candidate must be mentioned on the application as registered with IAP. No other change in the name will be allowed.

The nomination forms will be scrutinized by the Election officers for its validity. After scrutiny, the Chief Election officer shall send the list of valid candidates to the IAP-Bengaluru office for posting on its website. Each eligible candidate will also be intimated on his/her registered email address by the Election Committee (EC). Reasons for rejection of nominations can be requested by the candidate only, by sending an email (from the registered email id) on or before 11/11/2023 by 5:00 pm to the email ID of the Chief Election Officer. Any candidate whose nomination has been accepted can withdraw his / her nomination on or before 16/11/2023 by 5:00 pm. The decision of the IAP-Bengaluru Election Committee shall be final.

All the eligible Fellow / Life members, whose names appear on the IAP-Bengaluru 'Registry of Members' as of 31st July 2023, are eligible to participate in the IAP-Bengaluru election process. Each voter shall be entitled to cast one vote for each vacant post.

A soft copy of the list containing the names and addresses of Fellows and Life Members of the IAP Bengaluru shall be supplied directly by the IAP Bengaluru Office to the contestants on request. The Election Committee will not supply any voter list to any other member.

The Election Committee will have no role in the publication of the bio-data of the candidates.

Part II

Important Instructions to Members for IAP Bengaluru Elections for the year 2024

Only eligible Fellow / Life members of the Society shall be eligible to offer themselves as candidates for election. They are also eligible to propose or second the candidature of any one member. All the Members and Contestants shall strictly adhere to the following clauses of the Memorandum of Association of IAP Bengaluru.

17 Voting Rights

- 17 (a) The eligible voters' list shall be as per the Registry of Members as on 31st July of that year.
- **17 (b)** A Fellow/Life Member of IAP Bengaluru shall have the right to vote at any meetings or elections of the IAP Bengaluru.
- **17 (c)** An Associate Life Member shall not have voting rights at any meetings or elections of IAP Bengaluru.

19 Elections

19 (a) Election Committee

All the elections to the post of Office Bearers and Executive Board Members shall be conducted by an Election Committee composed of three Election Officers appointed every year by the Executive Board amongst the Life Members of the IAP Bengaluru.

The Election Officers shall be Life Members of IAP Bengaluru for at least 15 years.

The Chief Election Officer shall be chosen amongst the 3 Election Officers by the Executive Board.

A Member can be an Election Officer for a maximum period of 4 terms.

If during the tenure of the Election Committee, there arises a vacancy for the post of Election Officer due to any reason, the Executive Board has the authority to nominate any eligible member to that post and he shall continue for the following residual term of the Committee. This residual term shall not be counted as a term to calculate the maximum four-year period as a member of the Election Committee.

The office of the Election Committee shall be situated at the office of IAP Bengaluru.

None of the Election Officers can contest in any general election of IAP Bengaluru for the next two years after demitting office.

- **19 (a) (i)** The Election Committee once appointed shall become a quasi-autonomous body. Upon the notification of elections, the Election Committee shall function autonomously to conduct free and fair elections without any bias, hindrance, interference, favouritism, or influence from anyone.
- **19 (a) (ii)** The Election Committee shall enforce the Code of Conduct prescribed by the Executive Board from time to time.
- **19 (a) (iii)** The Election Committee shall submit the declaration of results/reports to the Secretary of IAP Bengaluru soon after the elections are over.

19 (b) Election Tribunal

An Election Tribunal consisting of three Past Presidents of IAP Bengaluru shall be constituted every year by the Executive Board. Any complaints regarding the elections shall be referred to the Election Tribunal to examine and submit its report to the Executive Board within two weeks of receipt of a complaint. The decision of the Executive Board shall be final and binding on all the parties concerned.

In case, a member of the Election Tribunal has any conflict of interest, he shall not be a member of that Election Tribunal.

- **19 (c)** Once the elections are declared by the Election Committee, the Code of Conduct as formulated by the Executive Board from time to time shall apply to all the contesting candidates.
- **19 (d)** A contesting member, if he is an Executive Board member of IAP Bengaluru/IAP, or any of its Branches, Chapters or Groups shall temporarily recuse himself from the responsibilities of that post which he has occupied in the said office until the code of conduct is in force.
- **19 (e)** Any member desirous of contesting for any post in IAP Bengaluru must have cleared all his dues (if any) to IAP Bengaluru and must have audited the accounts and duly certified by a chartered accountant as on 31st March of that year for the period which he has held any post in IAP Bengaluru, IAP or any of its affiliated bodies, before filing his nominations.
- **19 (f)** A Fellow or Life Member of IAP Bengaluru may propose any person who fulfils the conditions for election as a Member of IAP/ IAP Bengaluru in the category as applicable and such proposal shall be seconded by another Fellow or Life Member of IAP Bengaluru.
- **19 (g)** The election of Office Bearers and the Members of the Executive Board of IAP Bengaluru shall be held by the secret ballot/e-ballot, as per the guidelines framed by the Executive Board/General Body of IAP Bengaluru from time to time, which shall be in line with those of the IAP.
- **19 (h)** A member once elected as an Office Bearer shall not resign to the post and/or assume another post in IAP Bengaluru/IAP or its branches/chapters/groups till the period of the elected office is completed.
- **19 (i)** A Life Member contesting for the post of President should have been a member of the IAP Bengaluru for ten complete years on or before 1st January of the current year to be eligible to contest for the ensuing elections and should have served as the Executive Board Member of IAP Bengaluru for at least two terms and as an Office Bearer of IAP Bengaluru for at least two terms before contesting for the post of President.
- **19 (j)** A Life Member contesting for the post of Vice President should have been a member of the IAP Bengaluru for seven complete years on or before 1st January of the current year to be eligible to contest for the ensuing elections. He should have served at least one term as an Office Bearer of IAP Bengaluru and at least two terms as an Executive Board Member of IAP Bengaluru before contesting for the post of Vice President.
- **19 (k)** A Life Member contesting for the post of Secretary should have been a member of IAP Bengaluru for five complete years as on or before 1st January of the current year to be eligible to contest for the ensuing elections and should have served as an Executive Board Member of IAP Bengaluru for two terms before contesting for the post of Secretary.
- **19 (I)** A Life Member contesting for the post of Treasurer should have been a member of the IAP Bengaluru for five complete years as on or before 1st January of the current year to be eligible to contest for the ensuing elections and should have served as an Executive Board Member of IAP Bengaluru for two terms before contesting for the post of Treasurer.

19 (m) A Life Member contesting for the post of Joint Secretary should have been a member of IAP Bengaluru for five complete years as on or before 1st January of the current year to be eligible to contest for the ensuing elections and should have served as Executive Board Member of IAP Bengaluru for two terms before contesting for the post of Joint Secretary.

- **19 (n)** A Life Member contesting for the post of Executive Board Member:
 - a) should have been a member of IAP Bengaluru for three complete years as on or before 1st January of that year for the ensuing elections.
 - b) A Life Member can be elected as an Executive Board Member for a maximum of 4 terms only.
 - c) If elected as an Executive Board Member continuously for more than two terms, he shall not contest again to the post of Executive Board Member for the next two years.

19 (o) A Life Member

- a) If elected consecutively for four terms to the Executive Board, he shall not contest again in the elections for the next two years.
- b) Shall not contest for the lower post than the previous post he was elected to [This clause shall be applicable only prospectively and shall not apply to those who were already elected as Office Bearers in the past before the amendment of these bye-laws]
- c) A Life Member shall not simultaneously contest for more than one post at a time.
- **19 (p)** The hierarchy of lower to upper posts shall be in this order;
 - i. Executive Board Member
 - ii. Joint Secretary
 - iii. Treasurer
 - iv. Secretary
 - v. Vice President
 - vi. Immediate Past President
 - vii. President-Elect
 - viii. President

19 (q) Recounting of Votes

Any contestant who has any objection regarding the declaration of election result and desires to get the recounting of his votes (including e-voting/postal ballot/physical ballot) shall make a written request within 48 hours from the time of declaration of election result to the Chief Election Officer. The recounting in such cases shall be at the sole discretion of the Election Committee.

- Any member who has any complaint about the elections shall give the same in writing addressed to the President of IAP Bengaluru within seven days from the time of declaration of the results. Any recounting of votes in such cases if any shall be at the sole discretion of the Election Tribunal.
 - 19 (s) Any dispute arising out of elections shall be subject to the Jurisdiction of Bengaluru City.

Code of Conduct for the Election of Executive Board and Office Bearers of 'Indian Academy of Pediatrics - Bangalore Branch' with effect from date of filing of nomination.

The following are the components of the code of conduct:

A. The following actions are Not Allowed by contestants:

- I) Advertisements in lay press, any kind of press release, and interviews about the IAP Bengaluru election.
- ii) Placement of banners with personal names anywhere in the city.
- iii) Hosting of tea/lunch/dinner/cocktail parties for fellow members from IAP Bengaluru, other than Weddings in Immediate Family for which the Chief Election Officer has to be informed before & written permission taken by the Chief Election Officer, with submission of Proof (E.g., Wedding Card).
- iv) Negative propaganda about fellow contestants.
- v) Use of pressure, inducement, or coercion to get votes from fellow IAP Bengaluru members.
- vi) Impersonation of an eligible voter of IAP Bengaluru.

B. Appeals are allowed:

in the form of emails/ print /electronic media like election letters/ brochures / SMS / Telephone / digital platforms.

- C. Participation as faculty or delegate in programs of IAP/ IAP Bengaluru / Pharmaceutical companies
- 1. Pharmaceuticals and equipment manufacturing companies: After the release of the final list of contestants, the contestants shall not participate as faculty (Speaker/Panelist/Moderator or Chairperson) in any academic program including webinar platforms hosted by any Pharmaceutical Company anywhere in the country. Contestants will not be permitted to avail any assistance from Pharmaceutical/equipment manufacturers for any activity connected with the election. Contestants can be delegates at academic programs organized by the Pharmaceutical Industry (with the exception of the Infant Milk Substitutes Industry) but must pay for their own travel, accommodation, and registration.
- **2. IAP / IAP Bengaluru programs :** The contestants shall not be faculty (Speaker / panelists / moderator or Chairperson) / organizing team members / coordinators of any IAP program after the release of the final list of contestants.

This code will apply for both physical live academic and webinar activities in IAP Bengaluru.

Contestants can be delegates at academic programs organized by IAP but must pay for their own travel, accommodation, and registration.

Slide shows, Posters, distribution of Pamphlets, etc of Contestants inside the venue of any IAP activity is strictly prohibited.

D. Rules applicable for all the contestants:

- I) The candidate will have to recuse from all the posts after the release of final list of nominations.
- ii) They will not be a part of the organizing team hosting dinners or any other social programs.
- iii) If the Contestant was holding key posts of PEDICON organizing committee (The Chief organizing chair person, Chief Org. secretary, treasurer and all the official signatories) for the PEDICONS held before the election year while applying for nomination for election for any post will have to submit the final audited report and have no dues.
- iv) Sponsorship from Pharmaceutical or any Industry or Association or Person is disallowed for contestants, for posting / personal distribution of electioneering material such as letters and pamphlets or travel or accommodation etc. for self or family in or outside country for Academics or Pleasure.
- v) Ethics code of conduct of MCI will be applicable.

Any breach of this guideline should be brought to the attention of the EC.
